Welcome to the March edition of Copyright News, a quarterly update from RightsDirect for licensees and anyone interested in copyright and content in the workplace.

In the Spotlight: RightsDirect Announces Partnership with German Chemical Industry **Association VCI**

For research-driven companies and organizations the internal sharing and dissemination of third-party published content such as scientific articles is critical. This is specifically true for R&D operations within pharmaceutical and chemical corporations. However, most published content shared in the workspace is copyright-protected. And subscriptions or individually purchased articles rarely come with the re-use rights to share or store internally.



RightsDirect, German collecting society VG WORT and the Verband der Chemischen Industrie (VCI), with 1.650 corporate members the largest chemical industry association in Germany, have established a collaboration agreement. The VG WORT Digital Copyright License jointly created by RightsDirect and VG WORT, allows German companies and their international subsidiaries to share and re-use millions of publications from more than 400.000 German and international rightsholders while respecting the copyright of others. Under the agreement, VCI member companies now get a discount of 10% when obtaining the VG WORT Digital Copyright License.

Briefing: Open Access Doesn't Mean Free



Often times, consumers associate "open access" with "free content." However, freely accessible content is not necessarily the same as freely reusable content. Open Access content often includes restrictions on how it can be reused, including, for instance, whether or not it can be reused for commercial purposes. And of course, publishing costs still remain. Two prominent models exist to cover the costs for Open Access

publication: Green Open Access, which is supported by subscription revenue or Gold Open Access, in which case fees that offset publication costs are submitted ahead of publication.

Developed by RightsDirect's parent company, Copyright Clearance Center, and the Association of Learned and Professional Society Publishers (ALPSP), the Open Access Resource Center includes the latest on Open Access, broken down by region, including news, reports, whitepapers, websites and webinars. 
