Store articles for records, projects and/or product literature databases	\checkmark
Select and copy portions of digital articles and share with colleagues within your organisation worldwide	\checkmark
Attach copies of articles to internal communications such as newsletters, training materials and presentations	\checkmark
Share digital content internally via collaboration applications such as IBM® Notes® or MS SharePoint®	\checkmark
Scan printed works into digital form when an electronic version of the work is not readily available	\checkmark
Print out web-based or other digital content onto paper or overhead slides	\checkmark
Provide a single, responsive digital or print copy of an article to a customer or prospect upon request	\checkmark
Submit photocopied and digital copies of articles to government bodies for regulatory filings	\checkmark
